

The Rural University Consortium (RUC)

 Long-standing University Center partnership between BGSU Center for Regional Development (CRD) and the Voinovich School of Leadership and Public Affairs.

• CRD serves 27 counties in northwest Ohio while OU covers 32 counties in southeast Ohio (59 of the 88 counties in Ohio).

• The RUC scope of work is focused on workforce development, economic development technical assistance, applied research, and leadership development.







About the Center for Regional Development

- Regionally engaged research and technical assistance center at BGSU with expertise in economic and community development.
- Three full-time staff (Senior Director and two Economic Development Program Coordinators) and five graduate assistants
- Key areas of expertise include:
 - Applications for EDA funding for public works projects
 - Economic impact analysis
 - Economic and demographic data visualization and analysis
 - Regional planning process facilitation (CEDS, workforce, etc.)
 - Workforce development strategies and talent attraction efforts







Core Economic Development Technical Assistance

- Provide assistance to local governments, economic development officials, and regional planning organizations in support of applications for EDA Public Works and Economic Adjustment Assistance programs and CDBG grants.
 - Economic impact analysis
 - Demographic and economic information
 - Full application preparation
- Over past 5 years, CRD has assisted communities in securing \$8.5 million in federal grants which have leveraged \$360 million in private investment and supported 1,140 jobs in the region.
 - Nova Tube and Steel, LLC (\$70 million investment;
 102 new jobs)







Economic and Workforce Development Strategies: NW Ohio CEDS and 4CG Workforce Strategy

- CRD is leading the process to update the 3county Toledo region CEDS.
 - Supported by an EDA-EAA grant
- As part of its technical assistance program, CRD is working with the Village of Crestline on a CEDS.
 - Infrastructure needed to facilitate economic development projects.
- CRD partnered with Poggemeyer Design Group to develop a workforce development strategy for a four-county region along with a Talent & Attraction Implementation Plan.










Applied Research: 2019 TARTA Economic Impact Analysis

- CRD conducted an economic impact analysis for TARTA, the Toledo Regional Chamber of Commerce, the Toledo Metro Area Council of Governments (TMACOG) and the Area Committee on Aging.
- Provide elected officials with a sense of the economic contribution of TARTA to the region.
 - TARTA effort to change from property tax to county-wide sales tax funding base.
- CRD found that for every \$1 invested by taxpayers in TARTA, there is \$3 in economic output generated by TARTA.













2020 State of the Region Conference

- On March 2, 2020, CRD held its 18th Annual State of the Region Conference.
 - Developing Tomorrow's Workforce by Embracing and Investing in Robotics and Artificial Intelligence
 - Over 275 attendees.
- Program featured the following:
 - State of the Region Address by Russell Mills, CRD and Guhan Venkatu, Cleveland Federal Reserve Bank
 - Keynote Address by Molly Martin, Director, New America Indianapolis
 - Panel Discussion-Positioning Northwest Ohio to Be a Leader in AI and Robotics with Jennie Gallimore, Dean BGSU College of Technology, Ari Lewis, OhioX, Nathan Spoden, MedPilot, and Scott Lang, Motion Controls Robotics.








CRD and the COVID-19 Response

- CRD is working with several local governments and economic development organizations on applications for EDA CARES Act funding:
 - Infrastructure projects
 - Workforce and economic development strategies
 - Revolving Loan Funds
- CRD developed the Northwest Ohio COVID-19
 Resource Map for citizens, businesses, and local
 governments to easily locate recovery resources
 in the region.
 - Covers 17 counties within the CRD service area.
- CRD partnered with the BG Chamber and BG Economic Development on a COVID-19 business impact survey















About the Voinovich School of Leadership and Public Affairs – University Center



- Since 1996, OU & BGSU have jointly served as an EDA University Center covering 59 rural Ohio counties.
- Provide local economic development efforts access to economists and experienced economic development researchers who can assist with marketing and industry studies, competitor analysis, financial pro forma and modeling, cost-benefit analysis, and technology assessments.
- Provide coordination and technical assistance for the **Mayors' Partnership for Progress**. MPP is a consortium of mayors and managers from a 15-county region of Appalachia organized to provide a platform to share information, resources and best practices to address common local government and economic development issues.
- Offers an annual <u>Appalachian Ohio State of the Region conference</u> to build a shared understanding of regional economic challenges and opportunities.

Jackson County Hotel Feasibility Study

- Hubbell Boeing Construction proposing \$10 -12 million construction project for new hotel/restaurant in Jackson County, OH.
- Potential for 75 new hospitality jobs and 80+ temporary construction jobs.
- Developer estimates that the project will lead to a \$390,000 yearly increase in tax collections.
- Potential opportunity to leverage Ohio Enterprise Zone Program







OHIO unemployment – Feb. 5.0% vs. Apr. 21.5%

- Significantly impacted industries:
 - Food Service
 - Construction
 - Health Care
 - Social Assistance
 - Retail Trade
 - Manufacturing
- Local government tax loss revenue 10% 20%
- Marietta, OH Main Street survey 50 businesses responded
 - 50% of respondents business will PERMANENTLY close if condition lasted 5 months
 - 30% of respondents business will PERMANENTLY close if condition lasted 1-2 months

State unemployment in April 2020 21.5%
