This is an unclassified temporary position. You must be able to commit to a minimum of a 10/12-week assignment with an option to extend the assignment (120 days maximum) at the discretion of the Cuyahoga County Prosecutor. This internship program provides for a timelimited role at the Prosecutor's Office and does not express nor imply guaranteed future employment beyond the assignment period.

## **REQUIREMENTS:**

Undergraduate and/or graduate level students must be currently enrolled in a college or university program. Preferred educational background in criminology and/or political science. Students must receive college credit, complete an independent study, or receive federal work study funds for placement consideration in this internship opportunity.

## **FUNCTION:**

Interns will work physically in the office (no remote work option) to support the Cuyahoga County Prosecutor's Major Trial Unit (MTU). Projects may include assisting in the preparation for trial of homicide and sexual assault cases. In addition, interns will assist in the coordination of a multiple agency review of ongoing homicide and sexual assault investigations. There will also be an opportunity to work on reviewing applications for conviction integrity reviews.

#### **RESPONSIBILITIES:**

- Assist the prosecutor's office in reviewing ongoing homicide, sexual assault, and conviction integrity investigations;
- Assist with communicating with multiple law enforcement agencies;
- Read and synthesize police reports;
- Assist trial attorneys by creating written transcripts of audio and video recordings;
- Provided trial support to MTU trial attorneys;
- Provide support during meetings and review sessions;
- Assist with criminal history details of defendants and other persons of interest;
