Office of Field Services (OFS)

Who we are and what we do:

- ▶ OFS includes 7 team members and approximately 40 part time and faculty Supervisors
- ▶ We are in the Levin College of Public Affairs and Education
- ▶ We create partnerships with NE Ohio schools
- ▶ We coordinate all field experiences for CSU Education Students
- ▶ We support Interns during their final year experience

OFS Field Supervisor

Description of Position

- ▶ **Part Time, Contracted Position**
- ▶ **Responsible for overseeing a group of final year interns**
 - ▶ In the Field: develop and improve teaching skills, provide objective descriptions of Intern's abilities, observe Interns in the classroom, and collaborate with mentor teachers and CSU Seminar Leaders.
 - ▶ Behind the scenes: review student's work, maintain on-going communication, and produce letters of recommendation

OFS Field Supervisor Semester Responsibilities

- ▶ **Meetings: (All Fall Orientations are Virtual)**
 - ▶ New Supervisor Orientation (Only for new hires)
 - ▶ Supervisor/Seminar Leader Orientation (Week before semester begins)
 - ▶ Supervisor and Student Orientations (Week before semester begins)
 - ▶ Monthly Virtual Community Meetings (1-hr meetings are recorded and can be viewed at a later time)
- ▶ **Student Commitments:**
 - ▶ Complete 4-6 observations and give feedback: 4 for practicum and up to 6 for student teachers
 - ▶ Attend 2 virtual TRIAD meetings with Mentor Teacher and Student
 - ▶ Ongoing communication with students and mentor teachers (some supervisors set up weekly ZOOM meetings with students)
- ▶ **Technology used (OFS trains and supports supervisors on all technology):**
 - ▶ Blackboard (virtual classroom - houses GoReact)
 - ▶ GoReact (platform to upload videos and complete observations)
 - ▶ Taskstream (platform to upload CPAST scores and student documents)
 - ▶ ZOOM (all OFS meetings)

OFS Field Supervisor Intern Overview

▶ **Fall Semester (15 weeks)**

- ▶ Most students complete their practicum/internship 1 in the fall
 - ▶ 12 hours a week in the field
 - ▶ Supervisors complete 4 observations
 - ▶ Mid and Final TRIAD meeting with Supervisor and Mentor
- ▶ Some students are off cycle and complete their student teaching/internship 2 in the fall

▶ **Spring Semester (15 weeks)**

- ▶ Most students complete their student teaching/internship 2 in the spring
 - ▶ All day/5 days a week in the field
 - ▶ Supervisors complete up to 6 observations
 - ▶ Mid and Final TRIAD meeting with Supervisor and Mentor
- ▶ Some students are off cycle and complete their practicum/internship 1 in the spring

OFS Field Supervisor Payrate

- ▶ Supervisors are paid a flat rate per student which includes all meetings and responsibilities
- ▶ Contracts are processed each semester
- ▶ Payments are divided into 4 monthly payments over the semester
- ▶ Supervisors may also receive reimbursement for mileage if an in-person visit occurs. Mileage is based on the current government mileage rate from the Supervisor's home to the Intern's school.
- ▶ Service as a part-time single term instructor does not accrue tenure rights. Part-time single term instructors serve by the mutual agreement expressed in each successive contract executed and are engaged to teach at the convenience of the university.

OFS Field Supervisor Application Process

- ▶ Apply
 - ▶ All applicants must apply through the CSU Portal: <https://hrjobs.csuohio.edu/postings/9560>
 - ▶ Posting #PT0701368F
- ▶ OFS Search Timeline
 - ▶ Typically, OFS starts the Supervisor review in June for the next academic year
 - ▶ Occasionally, we have need mid-year and will review applicants in December
- ▶ Interview
 - ▶ Depending on need, we will reach out to specific licensure areas for an interview
 - ▶ Your application may remain in the portal until the next review depending on need
- ▶ On-Boarding
 - ▶ Once selected, we will be the on-boarding with CSU's Human Resource Department
- ▶ Starting the Semester
 - ▶ Prior to the semester, new Supervisors will attend a New Field Supervisor Orientation and learn about other training dates
